## 1 Scope

This standard includes nomenclature, dimensional data, performance criteria, and some interchangeable features for multi-use lighting poles. These poles shall be designed with clear separation per NEC/NESC requirements. The poles shall also have mounting provisions for antennas, radios, meters, disconnect switches, and any other equipment specified by the end user.

The intent of this standard is to establish the mechanical and dimensional requirements for the poles, which can be produced from steel, aluminum, and concrete.
